# RESOLUTIONS OF THE AMBA PEACE PLAN (APP) CONSTITUENT GENERAL ASSEMBLY (CGA) OF 3<sup>RD</sup> SEPTEMBER 2022

To the Restoration Council (RC) through the Chairman Honourable Elvis Kometa,

Due to the impasse in getting a response from the RC with regards to the preidentified irregularities in the Electoral Modalities, the President had to resort to public consultation with the Ambazonian people.

In the urgent APP CGA meeting convened by the President Mrs. Marianta Njomia on Saturday the 3rd of September 2022, with stakeholders from all 13 counties of the Federal Republic of Ambazonia, the Ambazonia People:

- -After critical analysis on the irregularities/flaws of the Electoral Modalities;
- -Acknowledging the non-responsiveness of the RC to the pre-identified irregularities/flaws of the Electoral Modalities;
- -Recognizing the desynchronization between the Executive and Legislative arms as the main element hindering the constitutionally prescribed reciprocal consultations required to ameliorate the Electoral Modalities to meet the democratic criteria of free, fair, and transparent elections;
- -Aware of the term of office of the current presidential mandate,

The Constituent General Assembly overwhelmingly voted and passed the motions to adopt the following resolutions:

RESOLUTIONS OF THE AMBA PEACE PLAN (APP) CONSTITUENT GENERAL ASSEMBLY (CGA) OF 3<sup>RD</sup> SEPT. 2022

### **RES. 1: Constituted LGAs**

To have at least two thirds (2/3) of the LGAs constituted (having voted at least 5 crucial executive roles) before sanctioning a presidential election.

(Voting: 92.6% For, 7.4% Against, 0% Abstention)

# **RES 2: Synchronization between Legislative and Executive arms**

The Ambazonian people imposed on the Executive and the Legislative arms to each put a working committee within two weeks of this day 3<sup>rd</sup> Sept. 2022 and work together to fix the Electoral Modalities to meet the democratic criteria for free, fair, and transparent elections. The joint Legislative-Executive Working Committee must report to the Ambazonian people through the APP Constituent General Assembly, within a onemonth period from this day, for adoption.

(Voting: 100% For, 0% Against, 0% Abstention)

# RES 3: Eligibility to vote and voting procedure

That only CID and AR-FEE subscribed citizens will vote at the level of their LGAs then each LGA will cast one vote by raising of the hand

in an open zoom/virtual meeting.

(Voting: 95.1% For, 4.9% Against, 0% Abstention)

### **RES 4: RC overhaul**

That the RC should be restructured before the presidential election and that only CID and ARF subscribers should be sent by the LGA to represent their constituency at the RC.

(Voting: 98.2% For, 1.8% Against, 0% Abstention)

## **RES 5: Electoral college**

That the electoral college will be ONLY the LGAs

(Voting: 98.1% For, 1.9% Against, 0% Abstention)

# **RES 6: Succession of mandate**

That the presidential elections are suspended, and the current presidential mandate is extended for 3 months pending attainment of resolutions 1-5.

(Voting: 100% For, 0% Against, 0% Abstention)
