Motto of the TECHNICAL Cabinet: Accountability & Action, Building Bridges and Complementary Commitment

Mindful of the United Nations General Assembly Resolution 1608 declaring the independence of the UN Trust Territory of British Southern Cameroons by Joining the Republic of Cameroon;

Mindful of the absence, since October 1st 1961 (Date of our Independence), of any Act of Union between the Republic of Cameroon and the UN Trust Territory British Southern Cameroons/Ambazonia as required by Resolution 1608;

Mindful of the rejection of the defacto Union between the Republic of Cameroon and our British Southern Cameroons/Ambazonia in 1972 by President Ahidjo through the unconstitutional change of the provision of the form of State;

Mindful of the official withdrawal of the Republic of Cameroon from the failed union in 1984 by President Paul Biya by legislating a revert to the original name of his component of the failed union;

Mindful of the establishment of our Interim Government of the Federal Republic of Ambazonia (Formerly Southern Cameroons) on October 1st 2017 by a constituent Assembly of Ambazonians;

Mindful of the establishment of the office of the President of the Federal Republic of Ambazonia/Southern Cameroons at the Fourth Conclave by a Constituent Assembly of Civil Society Organizations at home and in the Diaspora represented; Mindful of the Interim Constitution of the Federal Republic of Ambazonia signed on the 12th of June 2018;

Mindful of the resolutions of the constituent general assembly of the Ambazonian Stakeholders Strategic Conference (ASSC - BERLIN 2019) of Sunday the 14th of April 2019;

Mindful of both the current decommissioned status of the Restoration Council and the delegated presidential mandate stipulated in the resolutions of the Amba Peace Plan Constituent General Assembly of September 15th 2022;

By the powers conferred on me as President of the Federal Republic of Ambazonia (Southern Cameroons) on March 5th, 2022 by the RC of the Federal Republic of Ambazonia/Southern Cameroons and by the delegated mandate of the APP-CGA of 15th September 2022;
